REAL PROPERTY:

SUMMER TAXES are payable to the City of Trenton Treasurer thru August 31, 2021 without penalty. Beginning September 1, 2021 a 4% penalty will be added. ***Beginning March 1, 2022, taxes are delinquent and must be paid to: Wayne County Treasurer, 400 Monroe-5th Floor Detroit, MI 48226-2942 (313)224-5990 or at www.treasurer.waynecounty.com***

WINTER TAXES are payable to the City of Trenton Treasurer thru February 14, 2022 without penalty. Beginning February 15, 2022 a 4% penalty will be added. ***Beginning March 1, 2022, taxes are delinquent and must be paid to: Wayne County Treasurer, 400 Monroe-5th Floor Detroit, MI 48226-2942 (313)224-5990 or at www.treasurer.waynecounty.com***

PERSONAL PROPERTY:

Same as Real Property except that an additional penalty of 1% per month will be applied beginning March 1, 2022. ***Delinquent Personal Property Tax bills are payable only at the City of Trenton Treasurer's Office.***

2021 PERSONAL PROPERTY TAXES are based on assessments as of **DECEMBER 31, 2020.**
