**Whereas**, prior to executing any such agreements, contracts, or other legally binding documents, the Board deems it prudent to have its legal counsel review and approve all such agreements, contracts and other legally binding documentation as requested by the Board, and

**Whereas**, the Board is desirous of identifying and restating its members who are authorized to execute such documentation on behalf of the Board, therefore be it

**Resolved**, that this Resolution shall replace any previous signature resolution adopted by the Board, and further

**Resolved** that two Board signatures shall be required on all legally binding documents executed on behalf of the Board of Trustees of the City of Trenton Fire and Police Pension System, and further

**Resolved**, that the following Board members: Trustee Norris Blackledge, Trustee Bruce Jocks, Trustee Essen Davis, Trustee Michael McCullough, and Trustee Frank Cavazos, are hereby designated and authorized to execute all agreements, contracts, and other legally binding documentation in conjunction with the operation, administration and management of the Pension System in accordance with the provisions of Public Act 345 of 1937, as amended, and Public Act 314 of 1965, as amended, and further

**Resolved**, that upon execution by the Board in accordance with this Resolution, the Plan Secretary, Karen Sall shall be authorized to act on the Board's behalf in satisfying the administrative requirements that must be fulfilled for the timely and proper administration of the Retirement System, and further

**Resolved**, that the aforementioned authorized signatories shall sign this resolution as certified samples of each signature, and further

**Resolved**, that copies of this resolution shall be provided to appropriate parties as requested
